_____ TUITION

A non-refundable, non-transferable tuition for class is payable monthly (September 2021 through June 2022) on the **FIRST** lesson of each month. This applies whether the student is present or not. The placement time has been reserved for you and preparations made for your class. If the class payment is not received by the 15th of the month the latest, a \$25 late fee will be charged. Monthly payments that accumulate will also receive a return fee of \$25. Transaction fees of 3.5% will be applied if using a credit card and 1.75% + .25 if using a POS/debit card. Checks and Cash have no fees. (If there are extenuating circumstances, please let us know, we do not want any service interruption for the dancer.)

NEW STUDENTS: New students may try a class one time for a fee of \$20. If they sign up at the end of the class, the \$20 will be applied to tuition.

_____ ATTENDANCE

Regular attendance is expected. RDW students are expected to arrive on time. Inconsistent attendance can affect student's advancement and possibly remove their opportunity of performing with the class. If a student must miss a class, please notify the front office by phone 518-828-1130 up to an hour before class. We can make a ZOOM link available for distant participation in class or arrange to tape the class for later review. RDW does not return tuition payments for lessons not fulfilled. Students must be picked up promptly after class.

_____ RECITAL

A recital may be given during the year. Participation is encouraged but not required. An additional fee for costumes and tickets are required if student participates. There are no refunds for costumes at any time.

_____ DRESS CODE

Hair should be worn neatly off the face and fastened securely. This not only allows complete unrestricted movement, but also enables the Instructor to see the total line of the body. RDW students are expected to wear appropriate dance attire and footwear for all classes. All black tap, jazz, ballet or hip hop shoes or nude dance paws are required. NO JEANS, CUTOFFS, MID-SHIRTS, LOOSE JEWELRY are allowed in Studio as well as regular footwear on the dance floors. No chewing gum, candy, food or beverages other than water bottles are allowed in Studio.

_____ CLASS PLACEMENT

Class placement is based on technical merit. Age is used as a guide. Class placement is determined by the instructor for all levels. New students should talk to the office staff or instructor prior to signing up for a class to find the most appropriate fit for their age and dance level.

PARENT OBSERVATION

Parents will be provided a ZOOM link one week in December and one week in May to observe their dancer. A zoom link will be provided in an email prior to Observation Week.

WEATHER & HOLIDAY CANCELLATIONS

Please check in on our website (www.rozsdanceworks.com), Facebook page (Roz's Dance Works Hudson), and Instagram (Official Roz's Dance Works) for dance schedule changes, holidays off and cancellations due to inclement weather. It is the responsibility of the parent and student to know the schedule and to check on weather cancellations.
